



NCCP EVALUATION CHALLENGE EXPERIENCED COACH

Gymnastics Canada provides an opportunity for experienced, previously trained gymnastics coaches working in Canada to 'challenge' evaluations, so that instead of taking the required courses and then completing the evaluation, the coach proceeds directly to the evaluation.

This respects and recognizes current coaching competence, which includes Canadian coaches with significant coaching experience or related background, and foreign coaches with approved training and certification. To pursue recognition of coaching competence through Gymnastics Canada, coaches must successfully complete the evaluation process for the context in which they are coaching.

Coaches must apply for the opportunity to challenge an evaluation. The applicant must be a resident of Canada and must be working in Canada. Applications will be reviewed by Gymnastics Canada, who will determine the appropriate level of evaluation to challenge. This will be completed on a case by case basis. Some considerations may be given to special cases.

All applications must include a non-refundable cheque from the individual or organization requesting the evaluation challenge.

The fees are:

Gymnastics Foundations:	\$300.00

The procedure to apply for the opportunity to challenge an evaluation is:

- Applications must be sent directly from the coach or club to Gymnastics Canada.
- Applications must be written, and must include:
 - ✓ A cheque, payable to Gymnastics Canada, in the appropriate amount
 - ✓ A covering letter from the coach or club
 - ✓ An up to date resumé
 - ✓ A copy of the coach's school/university transcripts (if applicable)
 - ✓ A copy of the coach's coaching certification or accreditation documentation from their country of origin (if applicable)
 - ✓ An official letter confirming the coach's coaching status from their country of origin, and describing the level/names of athletes he/she coached and official competition results (if applicable)
 - ✓ Any other relevant information (FIG Brevet card, special honours received etc.)
- All documents must be officially translated, by a certified interpreter, to either English or French; copies of original and translated documents must be submitted.
- A minimum of 4 weeks is required to complete the application review process. Following the review, the candidate and the club will receive written notification from Gymnastics Canada as to the outcome. If the application is approved, Gymnastics Canada will provide the coach with an evaluation package and the contact information of potential evaluators.

HERE'S HOW TO APPLY!

You must apply for the opportunity to challenge a Gymnastics Canada evaluation. Your application must be approved by Gymnastics Canada, at which time we will put you in contact with a Gymnastics Canada evaluator.

Please complete and submit the attached application form with all the required documentation (including the application fee, payable to Gymnastics Canada).

Incomplete applications will be returned to the candidate, and will not be reviewed until complete documentation is provided.
