Overview

Launched in October 2022, Leap Gymnastics currently operates two centres in Mumbai training over 1000 gymnasts.

LGA aims to open multiple centres across the country with the twin aim of introducing the sport to a wider base of children (grassroots) and promoting excellence at the elite level in the mid to long-term.

Purpose

Leap Gymnastics is seeking a dynamic, innovative and responsible individual to take on a senior coaching role within our fast growing organisation. The Technical Education Manager will play a vital role in training and developing coaches who are responsible for the teaching of gymnasts who are various age groups and skill levels. The coach will focus on creating a safe, effective, and engaging learning environment that fosters the physical, mental, and emotional development of gymnasts.

Responsibilities:

- Plan and deliver gymnastics training sessions that cater to the needs and skill levels of athletes ranging from beginner to advanced.
- Instruct coaches on proper gymnastics techniques, including body positioning, balance, strength, flexibility, and coordination.
- Provide guidance and support to coaches during training sessions to promote skill acquisition and progression.
- Design and implement developmentally appropriate training programs with the coaches to ensure athletes' physical and mental growth.
- Create a safe and inclusive training environment, adhering to the highest standards of safety protocols and equipment maintenance.
- Assess athletes' progress regularly and provide constructive feedback to the coaches to help them improve their skills and achieve their goals.
- Assist coaches to develop individualized training plans for athletes based on their strengths, weaknesses, and competitive aspirations.
- Collaborate with other coaches and staff members to coordinate class schedules, training programs special events, and competitions.
- Oversee the delivery of classes across all venues to ensure consistency program content and teaching practices.
- Foster positive relationships with athletes, parents, and guardians, providing excellent customer service and addressing any concerns or inquiries.

- Ability to work flexible hours, including evenings and weekends, to accommodate training schedules and competitions.
